

## 格兰特·奥斯邦博士(Grant R. Osborne, Ph.D.)

格兰特·奥斯邦是美国伊利诺州三一神学院(Trinity Evangelical Divinity School)的新约教授,自 1977 年就在该学院任教。

在来到三一神学院以前,奥斯邦博士曾在威尼培神学院 (Winnipeg Theological Seminary)和阿伯丁大学(University of Aberdeen)任教。他也曾担任三一神学院的部分时间讲师两 年。

奥斯邦博士曾就读泰来大学(Taylor University),于福特源神学院(Fort Wayne Bible College)获颁宣教与牧会训练文学学士学位,于三一神学院获颁新约文学硕士学位,于苏格兰阿伯丁大学获颁新约博士学位。他也曾在英国的剑桥大学和德国的马尔堡大学(University of Marburg)从事学术研究。

奥斯邦博士的研究专长包括四福音、释经学和启示录。他是圣经文学学会(Society of Biblical Literature)、福音派神学学会(Evangelical Theological Society)和圣经研究学会(Institute of Biblical Research)的会员。

奥斯邦博士所著的书包括《福音书中的复活叙述文》(The Resurrection Narratives [Baker, 1984])、《基督教释经手册 - 释经学螺旋的原理和应用》(The Hermeneutical Spiral: A Comprehensive Introduction to Biblical Interpretation [InterVarsity, 1991])和《三个有关圣经的紧要问题》(Three Crucial Questions about the Bible [Baker, 1994, 2007])。他也写了启示录(Baker Exegetical series, 2002)、罗马书(IVP, 2004),马太福音(Zondervan, 2010),约翰福音(Cornerstone Series, Vol. 13, Tyndale House, 2007)和雅各书、彼得前、后书、犹大书(Cornerstone Series, Vol. 13, Tyndale House, 2011)的圣经注释书。此外,他也合著了《圣经研习手册》(Handbook for Bible Study [Baker, 1979])和《教会中的圣经》(The Bible in the Churches [Paulist, 1984]),并是以下书籍的编辑: IVP 新约注释系列(IVP New Testament Commentary series)、生活应用圣经注释(Life Application Bible Commentary [Baker])和新约研究面面观(The Face of New Testament Studies [Baker Academic, 2004])。奥斯邦博士也是由六人组成的新普及圣经译本(New Living Translation [1996])编委会的成员。

奥斯邦博士与他的妻子兰西居住在伊利诺州的黎波提庄(Libertyville, Illinois)。他们育有两名女儿,并有四名外孙女。闲暇时,奥斯邦博士喜爱旅行和自然研究。



Grant R. Osborne is professor of New Testament at Trinity Evangelical Divinity School in Deerfield, Illinois. He has been at Trinity since 1977.

Prior to coming to Trinity, Dr. Osborne taught at Winnipeg Theological Seminary and the University of Aberdeen. He also was a part-time instructor at Trinity for two years.

Dr. Osborne did undergraduate work at Taylor University and received the Bachelor of Arts in missions and pastoral training from Fort Wayne Bible College, the Master of Arts in New Testament from Trinity Evangelical Divinity School, and the Doctor of Philosophy in New Testament from the University of Aberdeen, Scotland. He has also done academic research at the University of Cambridge, England, and the University of Marburg, Germany.

Dr. Osborne's areas of expertise include the Gospels, hermeneutics, and the book of Revelation. He is a member of the Society of Biblical Literature, the Evangelical Theological Society, and the Institute of Biblical Research.

Dr. Osborne's published works include *The Resurrection Narratives* (Baker, 1984), *The Hermeneutical Spiral: A Comprehensive Introduction to Biblical Interpretation* (InterVarsity, 1991), and *Three Crucial Questions about the Bible* (Baker, 1994, 2007). He has also authored commentaries on Revelation (Baker Exegetical series, 2002), Romans (IVP series, 2004), Matthew (Zondervan, 2010), John (Cornerstone series, Vol. 13, Tyndale House, 2007), and James, 1-2 Peter, Jude (Cornerstone Series, Vol. 18, Tyndale House, 2011). He has also coauthored *Handbook for Bible Study* (Baker, 1979) and *The Bible in the Churches* (Paulist, 1984). Osborne is editor of the IVP New Testament Commentary series, the Life Application Bible Commentary (Baker), and *The Face of New Testament Studies* (Baker Academic, 2004). Dr. Osborne was also one of six editors in charge of the *New Living Translation* (1996).

Dr. Osborne and his wife, Nancy, reside in Libertyville, Illinois. They have two children and four grandchildren. In his spare time Dr. Osborne enjoys travel and nature studies.
